DEAN'S MEASURE NO. 9/2024 ON HEALTH SERVICES FOR STUDENTS

Art. 1

Subject of modification

- 1.1 The health care of students who have enrolled to study at the Faculty of Medicine in Pilsen, Charles University (hereinafter referred to as the "faculty") is ensured by a provider of health services chosen by students themselves according to Act No. 372/2011 Coll., on health services and conditions of their provision. The choice of the provider is not limited by the faculty.
- 1.2 During their studies at the faculty, students of all forms of study shall undergo:
 - a) An examination confirming medical fitness for study,
 - b) An exit preventive medical examination.

Art. 2

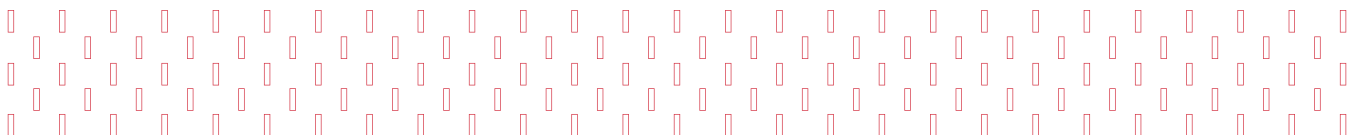
Certificate of medical fitness to study

- 2.1 All students undergo an examination confirming their medical fitness to study during the 1st year of their studies at the health service provider, in the scope specified by the implementing regulations.
- 2.2 A Certificate of medical fitness to study, stamped and signed by a general practitioner, shall be submitted by students enrolled in studies to the Student Affairs Department no later than March 31 of the academic year in which the student enrolled in the 1st year. The study department officer shall file the confirmation in the student's personal file and records the submission of the confirmation in the student's study report.
- 2.3 If a student fails to submit a certificate of medical fitness to study in time, he/she will not be enrolled in the next year.
- 2.4 The Certificate of Medical Fitness to study form is Annex No. 1 to this Measure.

Art. 3

Exit Preventive Medical Examination

- 3.1 During the last year of study all student shall undergo the exit preventive medical examination at the health service provider. The confirmation of the completion of the examination shall be submitted by the students to the study department by the end of the study, but no later than the date of the fulfillment of all study obligations given by the relevant study plan.
- 3.2 The study department officer files the confirmation in the student's personal file.



- 3.3 In the event that the student refuses to undergo this examination, the study department officer will record the refusal of the examination signed by the student and the study department officer. If the student refuses to sign this declaration, then the employee of the study department officer is obliged to make an accurate written record of this fact, which will be confirmed by the study department officer and the head of the study department. The same procedure applies to cases where a student has undergone an exit preventive medical examination, but has not documented this fact for any reason. These documents are always filed in the student's personal file.
- 3.4 The form with the confirmation of the exit preventive medical examination is Annex No. 2 to this measure.

Art. 4
Final Provision

- 4.1 The Certificate of preventive examination form according to the Dean's Measure No. 5/2014 remains valid for the transitional period of the academic year 2024/2025 for students who have already received it from the Study department.
- 4.2 This measure comes into force on the date of signature by the Dean of the Faculty and becomes effective from the academic year 2024/2025¹.
- 4.3 This measure cancels the Dean's Measure No. 2/2012 – State Exam Blocks Abroad, Dean's Measure No. 5/2014 – On Health Services for Students, Dean's Measure No. 12/2019 – Binding measure of the Faculty of Medicine in Pilsen, Charles University on the issues of measles incidence, Dean's Measure No. 8/2020 – Electronic registration of study results, Dean's Circular No. 3/2016 – Obligation of students to update personal data in SIS and , Dean's Order No. 6/2020 – Study obligations and requirements for the summer semester of the academic year 2019/2020.
