# DEAN'S MEASURE NO. 12/2024 RULES FOR GRANTING PATRONAGE

### Article 1 Subject of modification

This measure regulates the rules for granting the patronage of the Faculty of Medicine in Pilsen, Charles University (hereinafter referred to as the "faculty").

### Article 2

### Conditions for granting patronage by the faculty

- 2.1 Patronage is an honourable honour by which the Dean of the faculty grants moral support and draws attention to the importance and contribution of a given event, activity, project or undertaking (hereinafter referred to as "activity").
- 2.2 Patronage may be assumed over activities organized or arranged especially by basic and other departments for teaching and scientific research activities, special-purpose facilities and the dean's office and other entities associated with the faculty (e.g. student associations).
- 2.3 The request for patronage must be submitted in writing (paper or electronic) to the faculty office (e-mail: podatelna@lfp.cuni.cz) in sufficient time, at least 30 days before the activity.
- 2.4 Patronage is granted by decree of the Dean.
- 2.5 The granting of patronage does not entail the personal participation of a faculty representative in the organized activity, unless the Dean decides otherwise. If the applicant requests that a faculty representative attend the activity in person, the Dean will decide whether or not to support the request.

## Article 3

### Use of the faculty emblem for promotional purposes of student associations

The Dean of the Faculty agrees to the use of the faculty emblem to promote the activities of student associations under the following conditions:

- a) the promoted event or participation in it has been approved by the Dean of the faculty or the vicedean responsible for external relations,
- b) promotional materials with the faculty emblem will be used only for members of the association. When using the faculty emblem/logo, it is obligatory to follow the visual style of the faculty; information to the extent necessary will be provided by the PR and Marketing Officer.

#### Article 4 **Final Provision**

- 4.1 An integral part of this measure is Annex No. 1 Request for patronage by the Faculty of Medicine in Pilsen.
- 4.2 This measure comes into force and effect on the date of signature by the Dean of the Faculty.<sup>1</sup>
- 4.3 This measure cancels Dean's Measure No. 15/2020 Rules for granting patronage and Dean's Circular No. 2/2018 Use of the faculty emblem for promotional purposes of student associations.
