



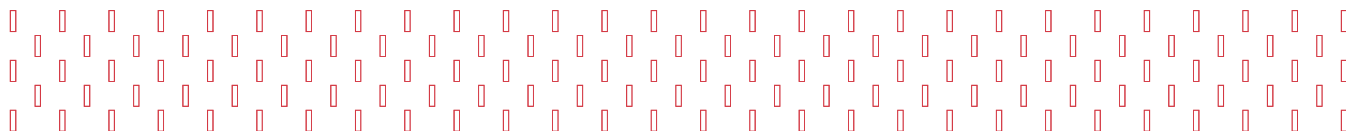

DEAN'S MEASURE NO. 1/2025

ON ENSURING THE POSSIBILITY OF CONTINUING STUDIES IN THE SAME OR SIMILAR STUDY PROGRAMME AT THE FACULTY OF MEDICINE IN PILSEN OF CHARLES UNIVERSITY

Article 1 Subject of modification

- 1.1 The Dean's measure is issued to implement Rector's Measure No. 9/2024, Details to ensure the possibility to continue studying the same or similar study programme in the event of termination of accreditation and the authorisation to carry out a study programme under institutional accreditation..
- 1.2 This measure regulates the details and organizational issues of ensuring the possibility to continue studying the same or similar study programme at the Faculty of Medicine in Pilsen of Charles University (hereinafter referred to as "the Faculty") in the event of termination of accreditation of the following doctoral study programmes:
 - a) Gynekologie a porodnictví;
 - b) Gynaecology and Obstetrics;
 - c) Lékařská farmakologie;
 - d) Medical Pharmacology;
 - e) Neurologie a psychiatrie;
 - f) Pediatrie;
 - g) Pediatrics;
 - h) Stomatologie;
 - i) Stomatology.
- 1.3 Study programmes are specified and implemented by study plans.
- 1.4 The degree completion plan serves to enable students to complete their studies in newly accredited degree programmes without major changes.



Article 2

Successor study programme

- 2.1 In its resolution of 19 June 2024, No. UKRUK/371687/2024-7, the Internal Evaluation Board of Charles University determined that the doctoral study programme Stomatologie, whose accreditation is terminated, is similar in content to the doctoral study programme Zubní lékařství, otorinolaryngologie a chirurgie hlavy a krku.
- 2.2 In its resolution of 19 June 2024, No. UKRUK/371687/2024-8, the Internal Evaluation Board of Charles University determined that the doctoral study programme Stomatology, whose accreditation is being terminated, is similar in content to the doctoral study programme Dentistry, Otorhinolaryngology and Head and Neck Surgery.
- 2.3 In its resolution of 18 September 2024, No. UKRUK/530157/2024-10, the Internal Evaluation Board of Charles University determined that the doctoral study programme Gynekologie a porodnictví, Pediatrie, whose accreditation is expiring, is similar in content to the doctoral study programme Gynekologie, porodnictví a pediatrie.
- 2.4 In its resolution of 18 September 2024, No. UKRUK/530157/2024-11, the Internal Evaluation Board of Charles University determined that the doctoral study programme Gynaecology and Obstetrics, Pediatrics, whose accreditation is terminated, is similar in content to the doctoral study programme Gynaecology, Obstetrics and Pediatrics.
- 2.5 In its resolution of 18 September 2024, No. UKRUK/530157/2024-22, the Internal Evaluation Board of Charles University determined that the doctoral study programme Neurologie a psychiatrie, whose accreditation is being terminated, is similar in content to the doctoral study programme Neurologie, psychiatrie a duševní zdraví.
- 2.6 In its resolution of 18 September 2024, No. UKRUK/530157/2024-2, the Internal Evaluation Board of Charles University determined that the PhD study programme Lékařská farmakologie, whose accreditation is being terminated, is similar in content to the doctoral study programme Personalizovaná diagnostika v onkologie.
- 2.7 In its resolution of 18 September 2024, No. UKRUK/530157/2024-3, the Internal Evaluation Board of Charles University determined that the doctoral study programme Medical Pharmacology, whose accreditation is being terminated, is similar in content to the doctoral study programme Personalized Diagnosis and Therapy in Oncology.

Article 3

Deadline for inclusion in the study plan for completion of studies

Students studying in the academic year 2024/2025 in the study programmes:

- a) Gynekologie a porodnictví;
- b) Gynaecology and Obstetrics;
- c) Lékařská farmakologie;
- d) Medical Pharmacology;
- e) Neurologie a psychiatrie;
- f) Pediatrie;
- g) Pediatrics;
- h) Stomatologie;



i) Stomatology

and persons whose studies in these study programmes are interrupted will be enrolled in a successor study programme and organisationally assigned to a study plan for completion of their studies as of 1 June 2025, and the subject board will assess whether it is necessary to update the individual study plan.

Article 4 Final Provision

This measure comes into force and effect on the date of signature by the Dean of the Faculty.¹
