DEAN'S MEASURE NO. 4/2025 SCHOLARSHIPS FOR STUDENTS OF THE DOCTORAL STUDY PROGRAMME

Article 1 Introductory provisions

In accordance with the Scholarship Regulations of Charles University and the Rules for Awarding Scholarships at the Faculty of Medicine in Pilsen of Charles University, the Dean of the Faculty of Medicine in Pilsen of Charles University (hereinafter referred to as "the Faculty") hereby clarifies and supplements certain details concerning doctoral scholarships at the Faculty.

Article 2 Doctoral scholarship

- 2.1 The basic amount of the doctoral scholarship is set as follows:
 - a) in the first year of the full-time form, 12 500 CZK per month,
 - b) in the second year of the full-time form is 12 500 CZK per month,
 - c) in the third year of the full-time form is 14 000 CZK per month,
 - d) in the fourth year of the full-time form is 14 500 CZK per month.
- 2.2 The awarding of amounts under Article 7, paragraph 3, letter a) and b) of the Rules for Awarding Scholarships at the Faculty of Medicine in Pilsen of Charles University is conditional on the confirmation of the Centre for Scientific Information that the obligation has been fulfilled by entering the publication into the OBD with the faculty's department next to the student's name.
- 2.3 In the event that the regular evaluation concludes that the individual study plan has been fulfilled and if the student is a student of a doctoral study programme achieving outstanding results in his/her studies, the Dean may, on the proposal of the supervisor or the departmental board, award the student an additional doctoral scholarship of up to CZK 30,000 on a one-off basis.¹
- 2.4 If the conclusion of the regular evaluation is that the student has not fulfilled some of the obligations according to the individual study plan, the Dean may, on the proposal of the departmental board,

award the student a doctoral scholarship for the next academic year in a lower amount or reduce the already awarded scholarship by up to 50%. The dean, on the proposal of the subject board, may increase the doctoral scholarship again in the light of the conclusion of the next regular evaluation. The re-increase of the doctoral scholarship is effective from the legal validity of the decision to increase the scholarship.²

2.5 In the event that the regular evaluation concludes that the student has not fulfilled the obligations according to the individual study plan, the Dean will decide to withdraw the scholarship.³

Article 3

Transitional and final provisions

- 3.1 This measure shall enter into force upon signature by the Dean and shall take effect on 1 March $2025.^{45}$
- 3.2 This measure fully cancels Dean's Measure No. 6/2018 Scholarships for students of the doctoral study programme.
